## Dear Evansville AGO Member,

The excitement is building as preparations continue for the Evansville AGO Chapter to host the Pipe Organ Encounter Advanced June 21-26. Recitalists and faculty instructors are arranged, accommodations are lined up, and plenty of interesting activities for the attendees are coming together. Activities will take place around the University of Evansville with organ practice and performance at U of E and churches in Evansville.

This is only the second POEA event to ever be held, so it is a great honor and great exposure for our chapter to be chosen to host this event. But, with that honor comes a great deal of responsibility for our chapter to put on a well-organized event. The help of every Evansville AGO member is very much needed. The AGO/POEA, just as most youth events, has increased the supervisory requirement for youth programs in order to strengthen the security and safety for both the attendees and the adult supervisors of these programs. We will need at least 20 volunteers each day to operate the program according to these expanded requirements. Volunteers do not have to be AGO members, so spouses and friends are welcome. The demands on our volunteers are not strenuous, but they do require some of your time. Mostly, the volunteer acts as a chaperone.

During the POEA, attendees will practice and have lessons with our outstanding faculty on organs at many Evansville locations. Each practice session and lesson requires an adult supervisor. Adult supervision is needed at these times: Monday, June 22 – 7:30am to 10:45am Tuesday, June 23 – 12:30pm to 3:45pm Wednesday, June 24 – 8:30am to 11:45am Thursday, June 25 – 7:30am to 10:45am

We will need some of our volunteers to provide transportation for themselves and 4 others to the practice/lesson locations. Indicate on the application form if you are able to provide transportation.

For everyone's protection (the POEA attendees, the AGO, and yourself) a background check is required. Even if you have had such a check for your current job or a prior job (teachers customarily need background checks), another is needed for this activity. The check includes criminal record, but not credit or driving records. Although you might not have encountered background checks previously, they have become standard practice for school, youth, and church organizations. We as the AGO can do no less than meet this contemporary standard for the assured security of our POE attendees.
